(hereinafter "TOHO HOLDINGS") is pleased to announce that its wholly owned subsidiary TOHO PHARMACEUTICAL CO., LTD., (Headquartered in Setagaya-ku, Tokyo; Hiroyuki Kono, President and Representative Director; hereinafter "TOHO PHARMACEUTICAL") has completed construction of its "TBC Kyushu" in Arao-shi, Kumamoto, as a new distribution center for prescription pharmaceuticals, etc., An outline of TBC Kyushu is as follows:

1. Purpose of the construction
